Sub.: Initiation of disciplinary action against erring SARCS / ICS / CEO's involved in illegal appointment of staff in PACS / LAMPCS.

Sir,

Consequent upon dissolution of Committee of Management of PACS/ LAMPCS, the Inspector of Cooperative Societies / CEO / SARCS working under Circle ARCS have been appointed as MIC, for smooth Management of the Societies. As such, so appointed MIC's are required to discharge their duties within the purview of the OCS Act and Rules as well as the provisions of the guidelines framed by Registrar of Cooperative Societies, Odisha governing the appointment and other conditions of services of the employees of PACS/ LAMPCS as communicated vide this office letter No. 2859 dated. 07.02.2011 and to maintain absolute transparency while managing the affairs of the societies. But in the meantime large number of public petitions alleging illegal activities of MIC's in appointment of staffs violating the provisions of OCS Act and Rules including the prescribed guidelines of Registrar of Cooperative Societies Odisha have been received by the under signed. Besides a good number of cases have also been filed before the Hon'ble High Court, Odisha challenging the illegal activities of MIC's and the Registrar of Cooperative Societies Odisha has been impleaded as an opposite party in such cases unnecessarily.

Therefore it is impressed upon you to ensure proper maintenance of the provisions of OCS Act and Rules as well as prescribed guidelines of Registrar of Cooperative Societies Odisha by the MIC's while managing the affairs of PACS/LAMPCS and initiate disciplinary action against the SARCS / ICS/ CEO's who have committed any illegalities in managing the affairs of the Societies violating the provisions of OCS Act and Rules as well as prescribed guidelines of Registrar of Cooperative Societies Odisha so far as the appointment of staffs is concerned. Further the M.I.C.s concerned may be asked to furnish the information with regard to any appointment made by him during his incumbency as M.I.C, at the earliest.

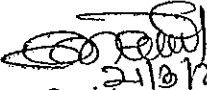
