Sub: According of approval by the Divisional DRCS and Circle ARCS in favour of PACS/
LAMPSCS for repairing/ renovation/ construction of buildings thereof

Sir,

With reference to your proposal submitted in your Letter No.2783 dt.06.02.2016 on the above subject, I am directed to say that the financial power of DRCS and ARCS for according approval of projects for repair/ renovation/ construction of buildings may be enhanced to Rs.3.00 lakhs and Rs 1.00 lakh respectively under the following conditions.

1. The estimate of the proposed project should be prepared by Government technical personnel.
2. The concerned DRCS/ ARCS are to ensure exploring of Government assisted fund/ projects for the above work by the PACS/ LAMPSCS and then to proceed for grant of approval.
3. The DRCS/ ARCS are to ensure that proposed construction is on the land recorded in the name of PACS/ LAMPSCS or in Cooperation Department and the funds shall be utilized as per Government procedure for public purpose only.
4. A Committee consisting of Circle ARCS, concerned CEO of the Block and the concerned Branch Manager of DCCB will be formed with Circle ARCS as its Chairman to review the progress of work, ensure proper utilization of funds and work completed. The work done is to be certified by the technical personnel of the Block. In case there is no CEO in the concerned Block, the ARCS is to nominate an ICS or SARCS of the office who is entrusted with the administrative supervision of that Block to the Committee. Similarly, the concerned Secretary of DCCB may nominate one Bank Official of Branch Manager or above cadre to the Committee where there is no Branch Manager. The Divisional DRCS is to review in the monthly divisional meeting.

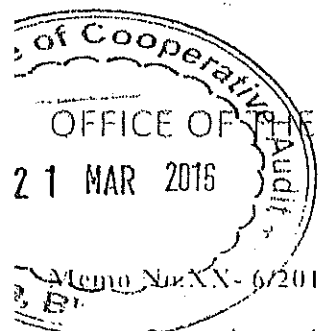
