Sub: Expedited Disposal of Surcharge cases and disposal of cases relating to PACS on priority basis.

Sir,

As you are aware, replenishment of PACS share is the most important aspect so far as revival package of 'Vaidyanathan Committee' is concerned for which disposal of Surcharge cases and restoration of funds etc. to the Society is necessary. Until and unless the share of PACS as assessed by special audit is funded, Govt. of India is not going to release its share to recapitalize the D.C.Bs.

But it is observed that huge cases of Surcharge Proceedings relating to PACS as well as other societies are pending with your circles since long. As it appears no sincere efforts has been made at your level to prepare a target oriented strategy for expeditious disposal of the cases despite repeated instructions from this Directorate. It is also seen that ~~within~~ the cases are either delayed unnecessarily due to frequent adjournments or proper action has not been taken to expedite disposal by hearing of cases in reasonably short dates. As a result of which huge cases remain pending for disposal. Govt. have taken a serious view about such non disposal of cases pending since long.

During review meeting held recently the Commissioner expressed her dissatisfaction for such poor disposal and desired that all the pending cases of

PACS should be disposed off on priority by 31.10.2010.

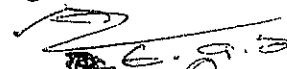
You are, therefore, instructed to review the pending position of cases of PACS of your circles and arrange in such a manner that hearing of the cases are made faster, if required, continuous hearing dates may be fixed and all cases initiated on the report up to the year 2003-04, should be disposed of within the date line. The SAGs entrusted with disposal of Swachh case be instructed accordingly to clear the pending cases of PACS assigned to them by October end, positively. The position of disposal cases is required to be reviewed every fortnight and progress intimated to this Directorate.

The cases relating to D.C.C.Bs and WCBs, maybe taken up expeditiously and it should be ensured to dispose of such cases as faster as possible.

Any deviation in this regard will be viewed seriously.

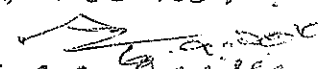
This should be treated as most important and urgent and compliance reported.
