Food and Procurement Policy for the Khariff Marketing Season (KMS) 2013-14.

Sir,

In enclosing herewith a copy of the Food and Procurement Policy for KMS 2013-14 of the State Government, communicated in the letter No. 18029 dated 19.10.2013 of Food Supplies & Consumer Welfare Department addressed to all Collectors, you are requested to implement the guidelines meticulously and ensure completion of following items of works immediately and report compliance.

1. Finalization of list of PACS and PPC by Collector.
2. Completion of PACS wise Farmers Paddy Assessment Register and submission of the same to BDO concerned.
3. Submission of PACS wise & village wise list of farmers to B.D.O. concerned.
4. Convening of first Society Level Procurement Committee meeting by Chief Executives of PACS immediately.
5. Registration of new PACS and Renewal of Registration of PACS involved in procurement operation in KMS 2012-13 with OSCSC.
6. Declaration of own PPC of PACS as market yard and availability of all prescribed equipments for procurement of paddy at PPC.
7. Arrangement either for availability of adequate godown facility at PPC point or providing of Covered and Plinth (CAP) Storage facility at PPC point.

A detail guidelines on procurement of paddy by PACS /MARKFED will be communicated immediately after receipt of the guidelines from Managing Director, Odisha State Civil Supplies Corporation.

You are requested to submit a weekly progress report in the enclosed format preparatory action taken on procurement of paddy by PACS till its completion. The first W.P.R. as on 02.11.2013 may please be furnished for appraisal of Registrar of Cooperative Societies, Odisha.
