Sir,

In enclosing copy of the letter no.3881 dt.18.5.2016 of the Principal Secretary to Government , Cooperation Department , I am to say that the Government has allowed utilization of the paddy procurement commission available with the PACS / LAMPCS / FSCS towards procurement of seeds from OAIC and OSSC with the condition that immediately after the sale of the seeds , the amount so withdrawn from the Savings Bank Account of PACS should be replenished without fail.

Therefore , in partial modification of the Directorate Circular No.16332 dt.10.9.2012 , it is further decided that the paddy procurement commission available with the PACS can also be utilized for the purpose of procurement of seed from OAIC and OSSC with the condition that immediately after the sale of the seeds , the amount so withdrawn from the Savings Bank Account should be deposited back without fail. The Chief Executive Officer of the DCCBs are authorized to allow withdrawal of required fund for the aforesaid purpose after receipt of a resolution adopted by the Committee of Management of the concerned PACS .

The Paddy Procurement Commission should be kept in a special SBD account to avoid mess-up with other account / fund.

Further , the Circle ARCS are requested to communicate the circular to all the PACS / LAMPCS / FSCS under their control under intimation to the undersigned.

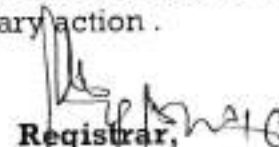

Sir,

Urgent.
Let's issue a circular to all concerned.
Please refer to your circular cited above in the matter of utilization of commission received by the PACS on paddy procurement operations. Substantial amounts on this account have been credited to a separate Savings Bank Account maintained at the level of Central Cooperative Banks and in your circular you have spelt out the modalities for spending the money for the purpose of infrastructure development.

You are aware that from this year, the Government has decided to distribute seeds to the farmers through the PACS for which, the Societies are required to purchase seeds from the Odisha State Seeds Corporation and Odisha Agro Industries Corporation on full payment of the proceeds. Adequate steps have been taken to engage all the PACS in this business for which the process of licensing is going on.

The PACS require immediate funds for purchase of seeds to make the same available to the farming community to start their operations. Now that, the Indian Metrological Department has forecasted that the monsoon would reach Odisha during first week of June, 2016, prepositioning of seeds has become a necessity.

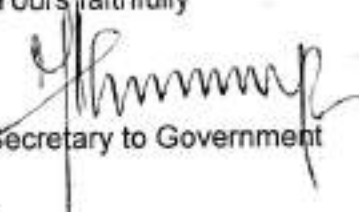

In order to facilitate immediate purchase of seeds, the funds available in the Savings Bank Account No. 3 of the PACS maintained at the CCB level in which, the paddy procurement commission has been deposited, may be utilized for the procurement of seeds from OAIC and OSSC, with the condition that after the sale of the seeds, the amount withdrawn from the Savings Bank Account should be replenished without fail.

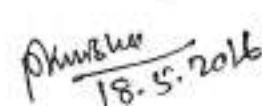
You are, therefore, advised to issue a circular in this regard to all the Central Cooperative Banks authorizing their Chief Executives to release funds from the Savings Bank Account concerned to the PACS for purchase of seeds with the condition as stipulated above. The circular in this regard should be issued immediately.
